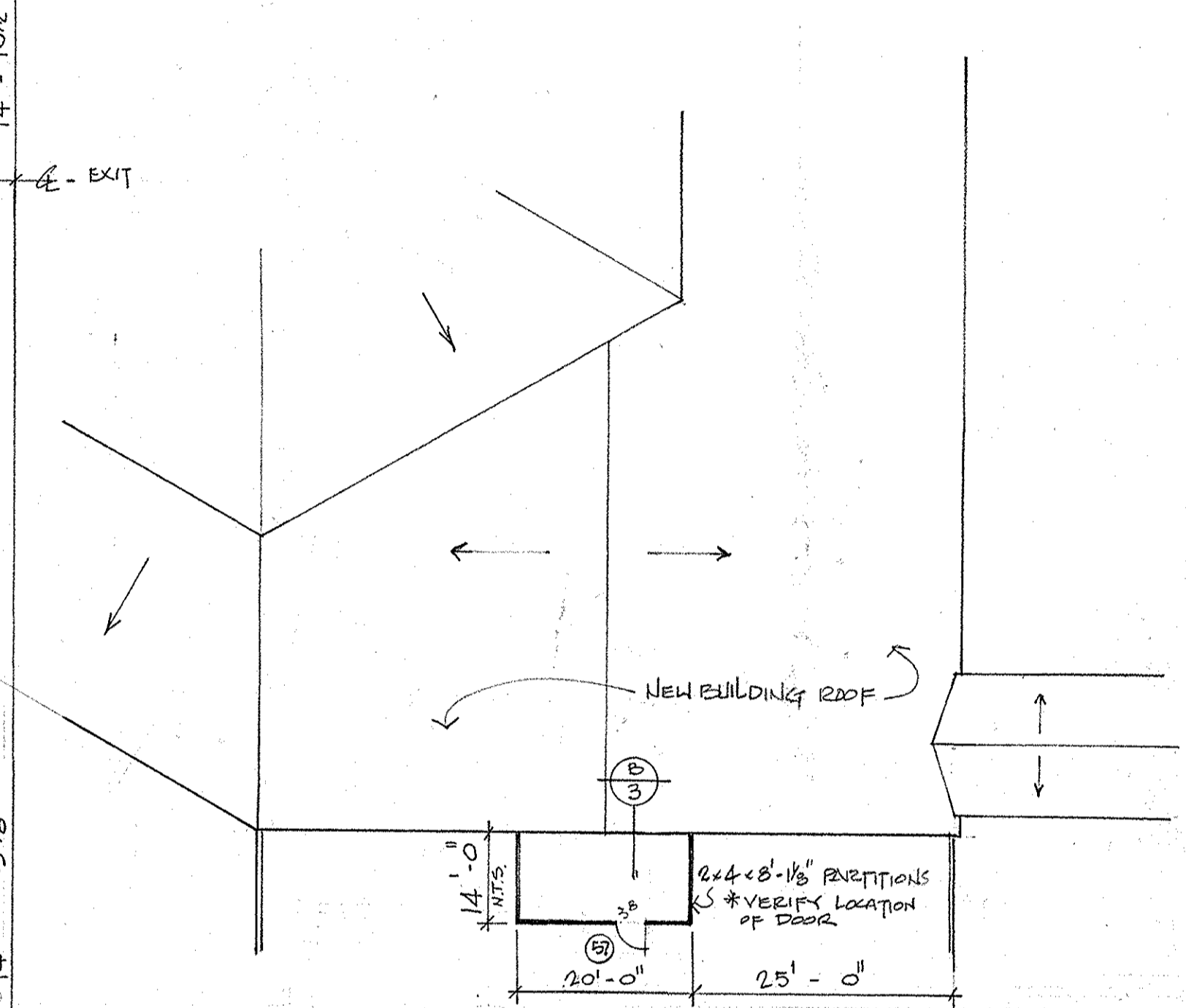


- NOTES:**
- 3/4 HR RATED PARTITIONS SHALL CONFORM TO UL DES 317
 - 2 HR FIRE HALLS SHALL BE CONSTRUCTED OF 3" SMALL MIN. WITH TYPE I AGGREGATE AND 1/2" THICKNESS OF SHELL MIN. - PROVIDE TENSILE JOINT REINFORCEMENT @ 16" O.C. PROVIDE VERTICAL REBAR AS REQ'D BY ENGINEERING DESIGN.
 - WHERE FIREHALL MEETS ROOF EXTEND NONCOMBUSTIBLE MATERIAL 24" MIN. TO ADDITION SIDE OF HALL. SEE DETAIL B.2.
 - ALL FIRE RATED PARTITIONS SHALL HAVE FIRE RATED DOORS & FRAMES:
 3/4 HR PARTITIONS - E LABEL DOORS & FRAMES
 2 HR PARTITIONS - E LABEL DOORS & FRAMES
 - EXTERIOR PERIMETER DIMENSIONS ARE BLOCK DIMENSIONS, ENGINEERING DEPARTMENT SHALL ADJUST WALL PANEL DESIGN ACCORDINGLY.
